> RE: Public Records Request Maalik Roquemore

Dear Ms. Gedeon:

The Cuyahoga Metropolitan Housing Authority (CMHA) is in receipt of your public records request dated April 27, 2023. Please allow this letter and documentation to serve as CMHA's response to each of your seven requests.

1. Full, complete, and unedited video and audio of the incident with Maalik Roquemore and CMHA Officer Ragland on 09/05/2022 including but not limited to all video provided to the Cleveland Police Department which was viewed by Ms. Kim Roquemore at the Cleveland Police Department the morning of her son's death.

RESPONSE: All video and audio to be produced in response to your request will not be produced "unedited" where redactions are either required or permitted by law. "If a public record contains information that is exempt from the duty to permit public inspection or to copy the public record, the public office or the person responsible for the public record shall make available all of the information within the public record that is not exempt."¹. Therefore, a public office may redact audio, video, and other electronic records by processes that obscure or delete specific content.

Your request is ambiguous as CMHA has no knowledge of what was viewed by Ms. Kim Roquemore at the Cleveland Division of Police ("CDP"). CMHA has produced video from Officer Desmond Ragland's ("Officer Ragland") body camera of the incident as well as all related dispatch audio.

Please be advised that redactions have been made to video for a "person's nude body" pursuant to ORC §149.43(A)(17)(h). Dispatch audio redactions have been made to personally identifiable information of CMHA residents. CMHA through its contract with the United States Department of Housing and Urban Development is required to comply with Federal Regulations including the Federal Privacy Act, 5 USC §552(a). Additionally, the Ohio Supreme Court has determined that if an item within a public record does not meet all the criteria of a public record and is personal information, it must be withheld. State ex rel. Dispatch Printing Company et al. v Johnson, (106 Ohio St 3d 160, 2005-Ohio-4384, 833 N.E.2d 274), State of Ohio ex rel. O'Shea & Associates Company, L.P.A. v Cuyahoga Metropolitan Housing Authority, (131 Ohio St. 3d 149, 2012-Ohio-115); vulnerability assessments pursuant to ORC §149.433(A)(2)(a) exempting infrastructure records; and peace officer personal information pursuant to ORC §149.433(A)(8) and State ex rel. Dispatch Printing Company et al. v Johnson, (106 Ohio St 3d 160, 2005-Ohio-4384, 833 N.E.2d 274), State of Ohio ex rel. O'Shea & Associates Company, L.P.A. v Cuyahoga Metropolitan Housing Authority, (131 Ohio St. 3d 149, 2012-Ohio-115).

2. Full, complete, and unedited video and audio of CMHA officer Ragland and all other CMHA officers that responded to the scene on 09/05/2022 with Maalik Roquemore.

RESPONSE: See Response to #1. Officer Ragland was the only officer on scene with Maalik Roquemore.

3. Full, complete, and unedited video and audio related to Maalik Roquemore of any and all CMHA officers that went to the hospital on 09/05/2022 – 09/06/2022.

RESPONSE: This request is ambiguous. If you are seeking video or audio from a hospital on 09/05/2022 – 09/06/2022, CMHA has no responsive records.

4. The complete investigative file related to Maalik Roquemore and the incident on 09/05/2022.

RESPONSE: CMHA Police Department (CMHA PD) is not the investigative agency in this matter, and thus does not have an investigative file. CPD is the investigative agency and CMHA PD turned over all the materials listed in Response #5 to CPD.
