On Saturday, February 25, 2023, the Ohio Bureau of Criminal Investigation (BCI) was contacted by the Middletown Police Department in Butler County, Ohio, to assist with an Officer-Involved Critical Incident that occurred at the Walmart, located at 2900 Towne Boulevard, Middletown, OH (Warren County) between Victor Lykins and the Middletown Police Department.

On Sunday, February 26, 2023, Special Agents Lauren Frazier and Douglas Eveslage attended the autopsy of Victor Lykins conducted by Chief Deputy Coroner Sean Swiatkowski at the Montgomery County Coroner's Office.

Dr. Swiatkowski provided a preliminary coroner's report (see attachment #01).
