Narrative:

On July 26, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent Steven Seitzman (SA Seitzman) requested the following records from Highland County Sheriff Donald Barrera (Sheriff Barrera):

- Any completed internal investigations relative to accidental discharges of the issued Sig Saur P320.
- Any and all complaints or concerns, formal or informal, your office has received by your staff regarding the Sig Sauer P320.

SA Seitzman received a response from Sheriff Barrera on July 26, 2022. Sheriff Barerra advised that on December 29, 2022, Highland County Sheriff's Office Special Deputy Phillip Porter (Deputy Porter) accidentally discharged his department-issued Sig Sauer P320. Sheriff Barerra sent SA Seitzman a coaching entry for the incident. The coaching entry revealed that Deputy Porter was handling the firearm in his bedroom when his "finger hit the trigger," causing a round to discharge.

SA Seitzman also received a letter from Sheriff Barrera indicating that his office had not received any formal complaints relative to the Sig Sauer P320 pistol. He stated that his chief deputy received a verbal complaint from a deputy prior to the purchase of the Sig Sauer P320 pistol; however, he said the deputy's complaint was that he personally preferred a different weapon.

The records received from Sheriff Barrera are attached below.

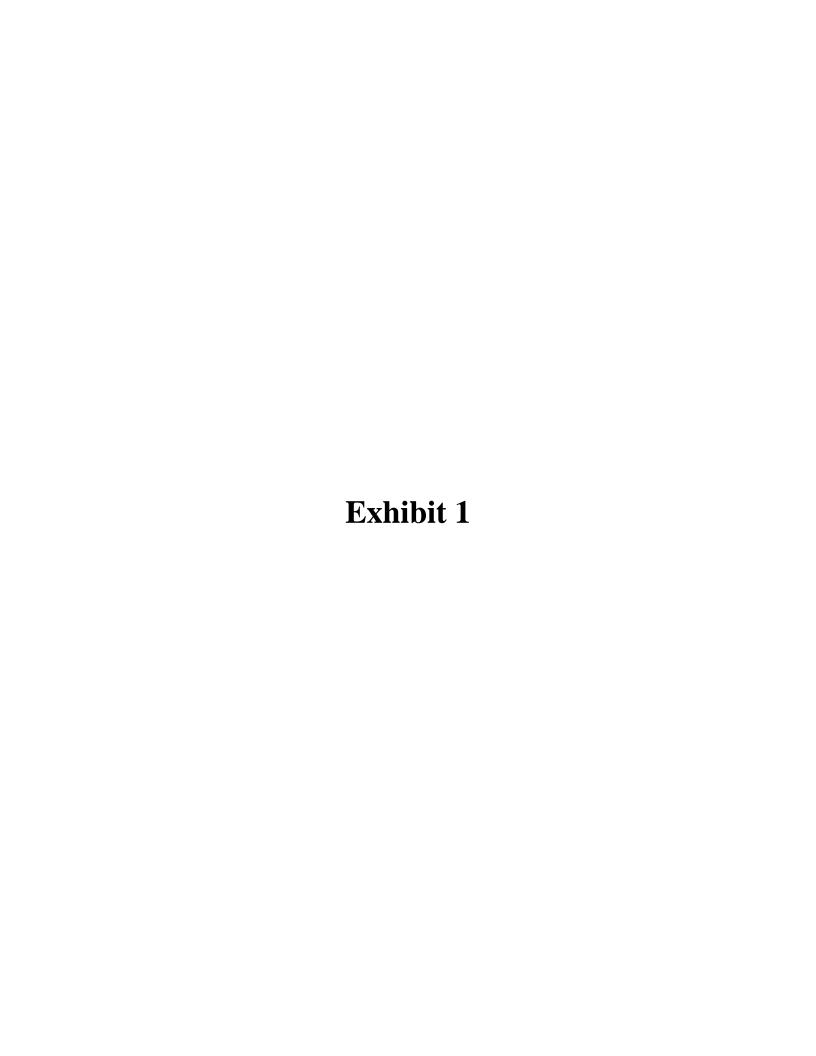



On December 29, 2020 Deputy Porter reported to myself and Deputy Hughes that he had an accidental discharge of his issued 9mm handgun in his home while off duty. He was handling the weapon in his bedroom when his finger hit the trigger. One round was discharged into a dresser in his bedroom. Deputy Porter was taken to the range by Deputy Hughes (range instructor) and re-qualified and instructed on handling procedures.
