Narrative:

On Tuesday, October 1, 2019, Ohio Bureau of Criminal Investigation (BCI) Special Agent Eric Lehnhart received a copy of a court order that was signed by Mansfield Municipal Court Judge Jerry Ault. A service copy of the court order was provided to OhioHealth Mansfield Hospital by the Richland County Sheriff's Office to produce the following information:

"Medical Records for Alexander J. Rios, DOB 05/08/1991, SSN: [REDACTED] pertaining to date September 20th 2019 through present date, including: Any and all medical records, Emergency Room Reports, Discharge Summaries, Operative Reports, History and Physical Clinic / Progress Notes, Drug / Alcohol Treatment, Radiology Reports, Laboratory Reports, Immunization Records."

On Tuesday, October 1, 2019, OhioHealth Mansfield Hospital produced the court ordered records. Special Agent Lehnhart obtained copies of these records from Captain Donald Zehner on Tuesday, October 1, 2019. A copy of the court order is attached to this report. Records Synopsis

Mansfield Fire Department

On Friday, September 20, 2019, at 0002 hours, Mansfield Fire Department Rescue One (1) responded to 73 East 2nd Street, Mansfield, Ohio 44902, the Richland County Jail for an unresponsive inmate with cardiopulmonary resuscitation (CPR) in progress.

After arriving on scene, paramedics and firefighters were led through the sally port garage to the jail booking room. Alexander J. Rios (Rios) presented to the responding medical team on the floor in a supine (on back) position with Deputy Lieutenant Steve Boyd performing CPR.

AFFIANT STATES THE FACTUAL BASIS FOR SUCH BELIEFS ARE:

THE AFFIANT HAS BEEN EMPLOYED WITH THE RICHLAND COUNTY SHERIFFS OFFICE FOR THE PAST SEVEN YEARS AND IS CURRENTLY ASSIGNED TO THE DETECTIVE BUREAU, THE AFFIANT HAS BEEN INVOLVED WITH NUMEROUS CRIMINAL INVESTIGATIONS AND HAS NUMEROUS HOURS OF CONTINUAL EDUCATION AND TRAINING IN LAW ENFORCEMENT AND CRIMINAL INVESTIGATIONS.

1. ON SEPTEMBER 20TH, 2019, INMATE ALEXANDER RIOS WAS CURRENTLY INCARCERATED AT THE RICHLAND COUNTY JAIL, LOCATED AT 73 E 2ND ST. MANSFIELD, OHIO IN RICHLAND COUNTY. INMATE RIOS WAS SUICIDAL WITH EXTREME CONFUSION, ERRATIC BEHAVIOR AND WAS BEING COMBATIVE WITH CORRECTION OFFICERS.
2. RCSO CORRECTION OFFICERS WERE HAVING DIFFICULTLY RESTRAINING INMATE RIOS, DUE TO HIS ENHANCED STRENGTH. INMATE RIOS BECAME UNRESPONSIVE AFTER BEING RESTRAINED BY CORRECTIONS OFFICERS. INMATE RIOS WAS TRANSPORTED TO OHIO HEALTH HOSPITAL FOR MEDICAL ATTENTION.
3. A SEARCH WAS CONDUCTED OF INMATE RIOS CELL. A SMALL CLEAR, PLASTIC BAGGIE WAS FOUND IN INMATE RIOS' CELL. IT IS BELIEVED THIS BAGGIE CONTAINED AN UNKNOWN DRUG. IT HAS BEEN COLLECTED AS EVIDENCE.
4. ON 09/27/2019 AT 1755 HOURS, INMATE ALEXANDER RIOS WAS PRONOUNCED DEAD AT OHIO HEALTH MANSFIELD HOSPITAL.
5. THE AFFIANT REQUESTS A SEARCH WARRANT TO OBTAIN MEDICAL RECORDS FROM OHIO HEALTH HOSPITAL, LOCATED AT 335 GLESSNER AVE MANSFIELD, OHIO IN RICHLAND COUNTY, FOR INMATE ALEXANDER RIOS, TO FURTHER THE INVESTIGATION.
