## Narrative:

On Friday, November 4, 2022, at about 0830 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Chuck Moran (Moran) received three Dual-Layer DVDs from the BCI Cyber Crimes Unit (CCU). The Dual-Layer DVDs were exact copies and contained BCI CCU Attachments A-D.

Previously, on October 7, 2022, SA Moran obtained a search warrant for a cell phone likely belonging to the subject, Jeremy McCracken, who was involved in an incident and subsequent officer-involved shooting on October 5, 2022, at about 1137 hours. The cell phone was collected from the living room of Jeremy McCracken's residence during the service of a search warrant.

In addition to the Dual-Layer DVDs with BCI CCU Attachments A-D, SA Moran received a copy of BCI Computer Forensic Specialist (CFS) Natasha Branam's (Branam) Analysis Report. Her report indicted the following evidence item was examined:

## <u>Summary:</u>

On October 7, 2022, Special Agent Charles Moran of the Ohio Bureau of Criminal Investigation received a warrant to search the contents of the below listed item. This item was to be analyzed for evidence relating to the crimes of Attempted Aggravated Murder of Law Enforcement Officer and Felonious Assault regarding the subject Jeremy McCracken.

Submitted Items:

012 – Mobile Phone – UMX U693CL

Details:

Item 12: Item 12 is an UMX manufactured mobile phone model U693CL. The International Mobile Equipment Identity (IMEI) number associated with Item 12 is 990015649948239 and the serial number is 693CL60521003014. Item 12 has an advertised internal storage capacity of 8 Gigabytes (GB) and is capable of additional storage through the use of a micro Secure Digital (SD) card. No additional storage was submitted with Item 12. Item 12 was placed into Airplane mode to suspend wireless communications. The device was connected to a forensic tool capable of obtaining a file system from the device. The extraction was then loaded into Cellebrite Physical Analyzer, a software package that converts the data to an easily readable format.

Item 12a: Item 12a is an unbranded Subscriber Identity Module (SIM) card bearing the Integrated Circuit Card Identifier (ICCID) 8901240154719045631.
