Narrative:

On January 6, 2023, the Ohio Bureau of Criminal Investigations were called by the Goshen Township Police Department in Clermont County, Ohio to assist with an Officer-Involved Critical Incident that occurred at 1785 State Route 28, Lot 419 AA, Goshen Township, Ohio, between the Goshen Township Police Department and subject Thomas Dewald Jr. (Thomas). Thomas was transported to Bethesda North Hospital 10500 Montgomery Road, Cincinnati, Ohio, and pronounced deceased once at the hospital.

On January 7, 2023, Special Agents Doug Eveslage and Lauren Frazier attended the autopsy of Thomas Dewald Jr. at the Hamilton County Coroner's Office, 4477 Carver Woods Drive, Cincinnati, Ohio, conducted by Forensic Pathologist Doctor Russell L. Uptegrove.

The attached Hamilton County Coroner's Office photos from Thomas's autopsy depict the hesitation cuts and the large laceration which cut the jugular vein.
