Investigative Activity: Akron Police Taser Downloads

Activity Date: August 3, 2022

Authoring Agent: Special Agent Cory Momchilov #64

On July 13, 2022, at approximately 1227 hours, Special Agent (SA) Cory Momchilov (Momchilov) submitted the following six (6) items to the Ohio BCI Cyber Crimes Unit for analysis:

- Taser X-26P-SN: belonging to Officer
 Taser X-26P-SN: 3 belonging to Officer
 Taser X-26P-SN: belonging to Officer
- Taser wire with probe
- Taser wire with probe
- Taser wire with probe

Ohio BCI Computer Forensic Specialist (CFS) Jarrod Scott (Scott) performed the analysis on the submitted items, (See report titled, "CCU Analysis Report of Tasers" for further detail). During CFS Scott's analysis of the Tasers, CFS Scott advised SA Momchilov that the Tasers were already downloaded on June 27, 2022 at 1130 hours, presumably by the Akron Police Department.

On June 26, 2022, SA Momchilov requested a copy of the Taser downloads from the Akron Police Department. On August 3, 2022, SA Momchilov was provided the following documents:

- Taser
- Taser
- Taser

SA Momchilov reviewed the documents and determined that the Taser Downloads provided by the Akron Police Department contained the same information reported by CFS Scott.




