Narrative:

On August 25, 2023 and August 31, 2023, Special Agent Jason Snyder (SA Snyder), with the Ohio Attorney General's Office Bureau of Criminal Investigation (BCI), received two (2) consent to search forms from Hannah Pawelski (Pawelski) for a silver Chevrolet Trailblazer LS, with Ohio License Plate KAW 06519 (Trailblazer).

The consent to search forms were requested by Pawelski for specific items that she wanted retrieved from the Trailblazer. These items were for the benefit of her child and herself to gain food and medical benefits. Based on the ongoing investigation, the items requested are not believed to be a part of the investigation.

The first consent to search form, which was filled out on August 25, 2023, was for baby care items. An inventory/Receipt was filled out and the items were given to Pawelski. Pawelski received and signed for the items that day (see receipt dated August 25, 2023 for a complete list of items Pawelski received).

On August 31, 2023, SA Snyder contacted the Van Wert County Prosecutor's Office, Prosecutor Eva J. Yarger (Pro. Yager). Pro Yager gave SA Snyder permission to retrieve items from the Trailblazer for Pawelski. SA Snyder opened the Trailblazer and retrieved the items on the Inventory/Receipt form dated August 31, 2023. The Trailblazer was resealed and SA Snyder affixed his initials to the new seal.

The items retrieved were a cell phone belonging to Pawelski, a state of Ohio food stamp card in the name of Pawelski, A debit card in Pawelski's name, and a medical card with Pawelski and her childs names affixed to it.

Pawelski received and signed for the items that day (see receipt dated August 31, 2023 for a complete list of items Pawelski received).
