**Narrative:**

On Friday, October 4, 2019, Ohio Bureau of Criminal Investigation (BCI) Special Agent Eric Lehnhart compiled background information on Alexander J. Rios (Rios), a subject involved in the incident on September 19, 2019. The information included researching past police reports involving the subject, searching criminal history records, court records (if applicable), open/closed-source database inquiries, and social media posts. The information gathered was obtained from the BCI Criminal Intelligence Unit and the Richland County Sheriff's Office Jail.

Special Agent Eric Lehnhart reviewed the information and noted the following:

Prior Police Encounters:

Rios had no prior encounters with the Richland County Sheriff's Office or the Richland County Jail prior to the service of the arrest warrant on Thursday, September, 19, 2019. The investigative case that initiated Rios' contact with the Richland County Sheriff's Office was filed by the Ohio State Highway Patrol.
