

On Tuesday, December 27, 2022 at 0908 hours, Summit County Medical Examiner (SCME) – Doctor Lisa Kohler (Kohler) conducted forensic autopsy of Zachary Dennis Zoran (Zoran) at the SCME offices, located at 85 North Summit Street, Akron (Summit County), Ohio 44308. SCME office identified the Zoran autopsy as SCME case #2022-004096.

Snyder attended the autopsy and learned the following information:



SCME personnel collected the following items of possible evidence during decedent Zoran autopsy:

- Head hair sample
- Pubic hair sample
- Right hand fingernail clippings
- Left hand fingernail clippings
- DNA blood standard card
- Inked fingerprint card
