## Details:

On April 19, 2022, at approximately 1335 hrs., S/A Justin Soroka met with S/A Arvin Clar at the Ohio Bureau of Criminal Investigation in Richfield to document the subject's clothing. S/A Clar had previously received the clothing and items collected during the autopsy from the Cuyahoga County Medical Examiner's Office. The items were secured in a temporary evidence locker at Ohio BCI.

Two, white socks, which were packaged separately by the Medical Examiner's Office, were photographed. The socks and their original packaging were packaged together and identified as item #13. A pair of Fruit of the Loom boxer briefs were photographed. The boxer briefs and their original packaging were packaged and identified as item #14. Two, camouflaged boots, which were packaged separately by the Medical Examiner's Office, were photographed. The boots and their original packaging were packaged together and identified as item #15. A blue shirt was photographed. Suspected bloodstains and a defect were observed in the general area of the front and center of the shirt. The shirt was cut, presumably by medical personnel. The shirt and its original packaging were packaged and identified as item #16. A pair of blue jeans were photographed. The blue jeans were cut, presumably by medical personnel. The blue jeans and their original packaging were packaged and identified as item #17. A grey, hooded sweatshirt was photographed. A defect was observed in the general area of the front and center of the sweatshirt. The sweatshirt was cut, presumably by medical personnel. The sweatshirt and its original packaging were packaged and identified as item #18. A grey, hooded jacket was photographed. The jacket was cut, presumably by medical personnel. The jacket and its original packaging were packaged and identified as item #19.

Standards of the subject's pubic hair and scalp hair were packaged separately by the Medical Examiner's Office. The hair standards were kept in their original packaging, packaged together, and identified as item #8. The subject's bloodstain card was identified as item #9. Swabs collected from under the fingernails of the subject, and swabs taken from the hands of the subject were packaged separately by the Medical Examiner's Office. The swabs were kept in their original packaging, packaged together, and identified as item #10. Gunshot residue swabs taken from both hands of the subject were identified as item #11. A bullet recovered from the subject was identified as item #12. All items were repackaged and then sealed and initialed by S/A Arvin Clar. All items were returned to temporary evidence locker #10.
