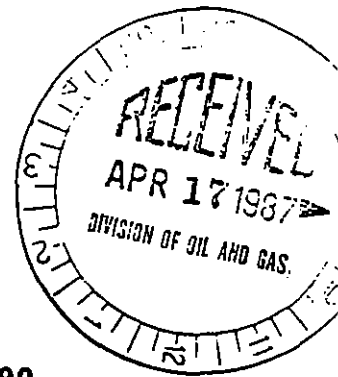

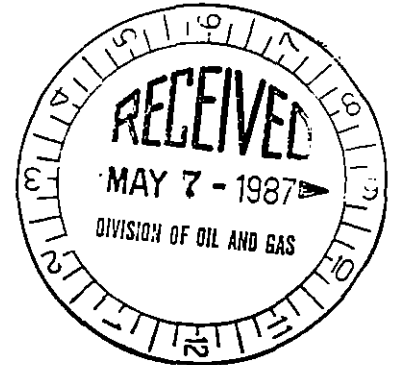

CONSENT ORDER

The Complaint having been filed on June 9, 1986 under Chapter 1509. of the Ohio Revised Code, and Plaintiff, State of Ohio by its Attorney General, Anthony J. Celebrezze, Jr. (hereinafter "Plaintiff") and the Defendant, Fortune Gas & Oil, Inc. having consented to this decree without trial of any issue of fact or law arising from the Complaint,

NOW, THEREFORE, upon the pleadings, and upon consent of the above-stated parties, it is ORDERED, ADJUDGED, AND DECREED as follows:

I

This Court has jurisdiction over the parties consenting to this decree, and over the subject matter of the action. The Complaint states a claim upon which relief may be granted under Chapter 1509. of the Ohio Revised Code.

II

This Court Judgment applies to Defendant, Fortune Oil & Gas, Inc., its subsidiaries, agents, employees, and successors, and to

all persons, firms, corporations, and other entities having notice of this Judgment and acting in privity with Defendant, Fortune Gas & Oil, Inc.

III

Defendant, Fortune Gas & Oil, Inc. is permanently enjoined from the violation of Sections 1509.03, 1509.072(A) and 1509.22 of the Ohio Revised Code and Rules 1501:9-3-04(A), 1501:9-3-11(B)(4), 1501:9-3-11(B)(5) and 1501:9-9-05 of the Ohio Administrative Code, at the Fox No. 1 well in Morgan County, Ohio.

IV

The Court hereby ORDERS that Defendant, Fortune Oil & Gas, Inc. pay a civil penalty in the amount of Ten Thousand Dollars (\$10,000.00). Payment shall be made by delivering to the Fiscal Section, Division of Oil and Gas, Fountain Square, Building A, Columbus, Ohio 43224, a certified check in the amount of Ten Thousand Dollars (\$10,000.00) by April 24, 1987. The certified check shall be made to the order of "Treasurer, State of Ohio". Payment of the civil penalty shall be in full satisfaction of any liability of Defendant, Fortune Gas & Oil, Inc. for the violations of Chapter 1509. asserted in the Complaint.

V

Defendant, Fortune Gas & Oil, Inc. shall pay all court costs.

VI

This Court retains jurisdiction over this action for the purpose of making any order or decree it may deem necessary to carry out this Consent Judgment.
