ENTRY OF DEFAULT JUDGMENT

Upon consideration of Plaintiff's Motion for Default Judgment at the hearing held August 25, 1994, the Court finds the motion well taken and that Defendant has failed to file an answer or to otherwise defend this case. Therefore, pursuant to Rule 55, the Court renders judgment by default in favor of Plaintiff. Therefore, it hereby ordered and decreed as follows:

A. Pursuant to R.C. § 6111.07(B), Defendant Fraternal Supplies, Inc. is permanently enjoined:

1. To comply with the requirements of R.C. Chapter 6111, the regulations promulgated thereunder, and Indirect Discharge Permit No.2PB00058100*AP ("Indirect Discharge Permit") (including any renewals and/or modifications thereof);
2. To submit to Ohio EPA, on or before each January 15 and June 15, a compliance monitoring report setting forth all of the information required by O.A.C. § 3745-3-06 and the Indirect Discharge Permit (including any renewals and/or modifications thereof); and
3. To comply with the indirect discharge limitations set forth in O.A.C. § 3745-3-12 and the Indirect Discharge Permit.

B. Pursuant to R.C. § 6111.09, Defendant Fraternal Supplies, Inc., is ordered, within fifteen days of entry of this Order, to pay to the State Treasury a civil penalty in the

amount of Seventy-Five Thousand Dollars (\$75,000.00) by submitting a certified check in that amount, payable to "Treasurer, State of Ohio," to Christopher A. Walker, Assistant Attorney General, 30 E. Broad St, 25th Floor, Columbus, Ohio 43215.
