JUDGMENT ENTRY

WHEREAS, on April 3, 1987, this Court appointed a receiver to bring Gibbs Industrial Park into compliance with water pollution control law; and

WHEREAS, on March 2, 1988, this Court issued its Opinion and Findings of Fact and Conclusion of Law that found Evelyn Gibbs in criminal contempt for interfering with the receiver and violating the April 3, 1987 Judgment Entry; and


WHEREAS, on March 4, 1988, this Court issued its Judgment Entry sentencing Evelyn Gibbs to thirty (30) days in jail and ordering her to pay a fine of \$250 for the criminal contempt; and

WHEREAS, on March 22, 1988, this Court issued its Judgment Entry ordering Evelyn Gibbs to serve the sentence of thirty (30) days in jail and pay the fine of \$250; and

WHEREAS, on December 20, 1993, the Lake County Court of Appeals upheld the criminal contempt finding and sanction, Ohio v. Gibbs (Dec. 20, 1993), Lake App. No. 13-073, et al.; and

WHEREAS, on June 8, 1994, the Supreme Court of Ohio in Case No. 94-384 overruled Evelyn Gibbs' motion to certify the record in Ohio v. Gibbs (Dec. 20, 1993), Lake App. No. 13-073, et al.;


NOW, THEREFORE, Evelyn Gibbs is hereby ordered to serve 30 days in the Lake County Jail commencing on Sept. 30, 1994 at 9:00 A.M. o'clock. By the commencement date, Evelyn Gibbs shall have payed the contempt fine of \$250 to Lake County and demonstrated such payment to counsel for the State.

WHEREAS, on December 20, 1993, the Lake County Court of Appeals upheld the criminal contempt finding and sanction, Ohio v. Gibbs (Dec. 20, 1993), Lake App. No. 13-073,

et al.; and


WHEREAS, on June 8, 1994, the Supreme Court of Ohio in Case No. 94-384 overruled Evelyn Gibbs' motion to certify the record in Ohio v. Gibbs (Dec. 20, 1993), Lake App. No. 13-073, et al.;

NOW, THEREFORE, the Judgment Entry of September 15, 1994 is vacated and Evelyn Gibbs is hereby ordered to serve 30 days in the Lake County Jail commencing on November 1, 1994 at 9:00 a.m. o'clock. By the commencement date, Evelyn Gibbs shall have paid the contempt fine of \$250 to Lake County and demonstrated such payment to counsel for the State.
