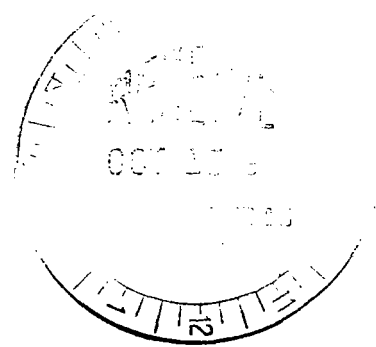

CONSENT ORDER

RESOURCE PRODUCTION, INC.

The complaint having been filed on October 19, 1984 under Chapter 1509. of the Ohio Revised Code; and Plaintiff, State of Ohio by its Attorney General, Anthony J. Celebrezze, Jr. (hereinafter "Plaintiff") and the Defendants Resource Production, Inc. and Robert A. Albrecht having consented to this decree without trial of any issue of fact or law arising from the Complaint,

NOW, THEREFORE, upon the pleadings, and upon consent of the above-stated parties, it is ORDERED, ADJUDGED, AND DECREED as follows:

I

This Court has jurisdiction over the parties consenting to this decree, and over the subject matter of the action. The Complaint states a claim upon which relief may be granted under Chapter 1509. of the Ohio Revised Code.

II

This Court Judgment applies to Defendants Resource Production, Inc. and Robert H. Albrecht, their subsidiaries, agents, employees, and successors, and to

all persons, firms, corporations, and other entities having notice of this Judgment and acting in privity with Defendants Resource Production, Inc. or Robert H. Albrecht.

III

Defendants Resource Production, Inc. and Robert H. Albrecht are permanently enjoined from the violation of Sections 1509.03 and 1509.22 of the Ohio Revised Code and Sections 1501:9-3-08(A), 1501:9-3-04(A) and 1501:9-1-07 of the Ohio Administrative Code, at the Clement Morris No. 1 well in Morgan County, Ohio.

IV

The Court hereby ORDERS that Defendant Resource Production, Inc. and Robert H. Albrecht pay a civil penalty in the amount of Five Thousand Dollars (\$5,000). Payment shall be made by delivering to the Fiscal Section, Division of Oil and Gas, Fountain Square, Building A, Columbus, Ohio 43224, a certified check in the amount of Five Thousand Dollars (\$5,000) by November 15, 1986; or in the alternative, One Thousand One Hundred Dollars (\$1,100) by the fifteenth of every month with payments beginning on November 15, 1986, until the defendants pay the penalty in full. The certified checks shall be made to the order of "Treasurer, State of Ohio".

V

This Court retains jurisdiction over this action for the purpose of making any order or decree it may deem necessary to carry out this Consent Judgment.

VI

Defendants Resource Production, Inc. and Robert H. Albrecht shall pay all court costs.
