The Complaint having been filed under Sections 3704.05 and 3704.06 of the Ohio Revised Code to enforce the air pollution statutes, and Plaintiff and Defendant by their respective attorneys having consented to the entry of this Consent Judgment;

Therefore, before the taking of any testimony, upon the pleadings and upon the consent of the parties hereto, it is hereby ordered, adjudged, and decreed as follows:

I. JURISDICTION

1. The Court has jurisdiction over the parties and the subject matter of this action. The Complaint states a claim upon which relief can be granted against Defendant under O.R.C. Sections 3704.05 and 3704.06.

## II. PERSONS BOUND

2. The provisions of this Consent Judgment shall apply to and be binding upon the parties to this action, including the successors and assigns of each, as well as any agencies, officers, directors, agents, and servants thereof, and of any party having notice of this Consent Judgment. This Consent Judgment is entered in full and final settlement of State of Ohio, ex rel. Anthony J. Celebrezze, Jr., Attorney General of Ohio v. Shiffer Corporation, et al., Case No. 66309, filed on October 31, 1983.

## III. COMPLIANCE


Defendants are ordered that they will not cause, permit, or allow the installation or operation of a new or existing source of air pollution as defined by Ohio Administrative Code Section 3745-31-01(1) without first applying for and obtaining permits to install and to operate as required by Ohio Revised Code Chapter 3704 and Ohio Administrative Code Sections 3745-31-02 and 3745-35-02 and are permanently enjoined from violating Ohio Revised Code Chapter 3704 and the regulations adopted thereunder.

## IV. DURATION


The Court retains jurisdiction of this case for the purpose of making any order or decree which it may deem at any time to be necessary to carry out this grant.

V. COSTS


Defendants shall pay Court costs.


