JOURNAL ENTRY AND CONSENT ORDER

The Complaint having been filed on March 28, 1988 under R.C. Chapter 1509; and Plaintiff State of Ohio and Defendant James Jackson (hereinafter referred to as "Defendant") having consented, without trial or adjudication of any issue of fact or law herein, to the entry of this Journal Entry and Consent Order;

THEREFORE, before the taking of any testimony, upon the Complaint and the consent of the parties hereto, this Court hereby ORDERS and DECREES as follows:

I

This Court has jurisdiction of the parties and of the subject matter of this case pursuant to R.C. Chapter 1509. Venue is proper in this Court. Defendant consents to the entry of this Journal Entry and Consent Order and waives any objection he may



have with respect to the sufficiency of the Complaint for the purpose of settling the claims alleged in the Complaint.

## II

The provisions of this Judgment Entry and Consent Order shall apply to and be binding upon the signatories hereto, their agents, officers, employees, assignees, heirs and successors in interest.

## III

In its Complaint, Plaintiff State of Ohio has alleged that Defendants violated certain R.C. Chapter 1509 sections and Ohio Administrative Code Rules at the Mincks No. 2 well and the Slate No. 1 well.

## IV

It is understood and agreed that Defendant James Jackson admits no liability as to any allegation of the Complaint and that payment of any monies pursuant to this Journal Entry and Consent Order shall not be construed as an admission of liability on the part of said Defendant. Defendant agrees to pay to Plaintiff State of Ohio a civil penalty of Two Thousand and xx/100 Dollars (\$2,000.00) by delivering to Plaintiff State of Ohio's counsel, for payment into the State Treasury, a certified check in such amount to the order of "Treasurer, State of Ohio" within ten (10) days after the entry of this Journal Entry and Consent Order. Such payment shall constitute full satisfaction of any potential but as yet undetermined liability of Defendant to the State of

Ohio for any allegations of violation of R.C. Chapter 1509 and Ohio Administrative Code rules asserted in the Complaint.

By executing this Journal Entry and Consent Order, Plaintiff State of Ohio does not discharge, release, or in any way affect any right, demand, claim, or cause of action which Plaintiff State of Ohio has, or may have, against any other party other than James Jackson, and Plaintiff State of Ohio herein expressly reserves for further enforcement all rights, demands, claims, and causes of action which it has, or may have, against all other Defendants in this action.

V

This Court retains jurisdiction of this action for the purpose of making any order or decree it may deem necessary to carry out this Journal Entry and Consent Order.

VI


This Journal Entry and Consent Order shall constitute a final order between Plaintiff State of Ohio and Defendant James Jackson.

VII

Defendant agrees to pay it's proportional share of the Court costs of this action.

VIII


Defendant states that he has read and fully understands this Journal Entry and Consent Order and agrees to comply with it fully.
