**Cleaning Up Dump Sites and Preventing
Future Dumping in Ohio Communities**

Background

Open dumping of solid waste and demolition debris is a significant problem for many communities throughout Ohio – one that affects big cities, villages and rural areas alike.

This environmental challenge has drawn plenty of media attention, including a Spectrum News 1 report this year about the considerable costs of illegal dumping. The Dayton Public Works Department recently told WHIO-TV (Channel 7) that cleaning up illegal dumping is a “constant battle” for the department, and the city of Cincinnati said it typically spends as much as \$4 million annually to clean up litter and illegally dumped waste and debris in its neighborhoods.

The persistent issues statewide prompted Ohio Attorney General Dave Yost in 2023 to launch an initiative to help communities expose dumpers who trash Ohio. “Shine a Light on Dumpers” is a multipronged campaign aimed at holding accountable those who open-dump solid wastes and demolition debris and eliminating these inexcusable eyesores from our communities.

“We want local law enforcement, prosecutors and the public to know what they can do to combat the unsightly and unhealthy problem of dumping – and how my office can help them,” Yost said. “It’s time to reclaim our communities from these polluters.”

Shine a Light on Dumpers consists of training, education, legal guidance, technical-equipment loans, and investigative and prosecutorial assistance. Our experts provide these resources to local law enforcement agencies and prosecutor’s offices so that those agencies (with help from the public) are equipped to stop illegal dumping.

Grant summary

In addition to helping to catch those who illegally pollute Ohio’s neighborhoods, the office of Ohio Attorney General Dave Yost wants to help communities remedy the dump sites. To that end, the Attorney General plans to use \$1 million in settlement money negotiated by his office to establish grants to help counties and local governments with such efforts.

County and local governments can apply for a grant to clean up an existing solid-waste dump site or construction-and-demolition-debris dump site or use grant dollars to take preventative action to deter future dumping.

The Attorney General’s Office will award grants of up to:

- \$100,000 for a county or local government to pay to clean up a dump site (or dump sites) in its jurisdiction.
- \$20,000 for a county or local government to purchase signs, gates, barriers or other structures to deter future illegal dumping.

The initial application period runs through Feb. 28, 2025, with applications being reviewed and grants awarded during this same period and thereafter on a first-come, first-served basis.

The decisions will be based on these key priorities:

- The applicant has no available resources to clean up the dump site or install signs or structures to prevent future open dumping.
- There are no other funds, programs or grants available to pay for the site cleanup or the installation of signs or structures.
- The dump site is a nuisance or blight to the community.
- The dump site is in a residential area or presents a threat to the environment.
- The dump site is owned by a local or county government.

Qualifying expenses

Eligible expenses under this grant program:

- Costs associated with the removal and proper disposal of solid waste and construction and demolition debris that have been open-dumped or illegally discarded, including those for:
 - Necessary services for public or private contractors.
 - Rental of equipment, tools and supplies.
 - Transportation.
 - Licensed-landfill or transfer-station fees.
 - Required permits.
- Costs of materials or equipment – including signs, gates, chains, poles or other structures – to deter or restrict an area that has been used for open dumping to prevent future dumping.

Ineligible expenses under this grant program:

- Costs that fail to meet the definition of “eligible expenses”
- Employee salaries, benefits, or administrative costs
- Financial services and grant-writing fees
- Land acquisition
- Replacement/reimbursement of Grantee’s operational funds
- Political campaign, political action committee, or governmental lobbying in a partisan manner

Required information

In addition to the completed application form, please include the following with your application:

- Expense projections or bid estimates.
- Photographs of the dump site.

Notice regarding application review

A committee of representatives from the Ohio Attorney General's Office will review all applications and have the final say on the winning submissions. The review committee may request additional information or documentation from applicants before making decisions.
