This case came on for consideration as a statutory unemployment compensation appeal filed by Appellant Ayrica L. Raglin ("Raglin") on January 20, 2012 under R.C. 4141.282. Raglin appeals from the final *Decision* of the Ohio Unemployment Compensation Review Commission ("UCRC") mailed December 21, 2011 that held that Raglin had failed to file a timely appeal from a Redetermination of the Appellee, Director, Ohio Department of Job and Family Services (the "Director"), denying Raglin Trade Readjustment Allowances ("TRA") benefits.

After due consideration of the evidence in the certified record, the Court hereby modifies the Decision of the UCRC as follows. Specifically, the Court hereby modifies the Decision to provide that Raglin is entitled to TRA benefits as follows:

- 1) Basic TRA benefits April 17 through April 30, 2011 in the sum of \$816 and
- 2) Additional TRA benefits May 1 through December 3, 2011 in the sum of \$11,232.

The Director shall pay the sum of \$12,048 following the entry of this order.

The *Decision* is further modified to provide that Raglin may be entitled to approximately eighteen (18) additional weeks of Additional TRA benefits provided that Raglin files a timely claim to reopen her file with the Director. Determination of such eligibility and the amount of any benefits payable will be made following the filing of a claim to reopen Raglin's file. The entry of this order is not a determination that Raglin will be entitled to additional TRA benefits.

Final judgment is hereby granted in favor of the Director, Ohio Department of Job and Family Services.
