**DECISION AND JUDGMENT ENTRY**  
**DISMISSING FOR LACK OF JURISDICTION AND**  
**NOTICE OF FINAL APPEALABLE ORDER**

SHEWARD, JUDGE

This is an administrative appeal governed by R.C. §119.12.

In *Foreman v. Lucas Cty. Court of Common Pleas*, 2010-Ohio-4731, the Tenth District Court of Appeals held that a notice of appeal filed under R.C. §119.12 must state that “the agency’s order is not supported by reliable, probative, and substantial evidence and is not in accordance with law.” The Foreman Court stated that strict adherence to the requirements of R.C. §119.12 is necessary to invoke the trial court’s jurisdiction over an administrative appeal. The Court held that when the quoted language is not included in the notice of appeal, the trial court lacks subject-matter jurisdiction to hear the appeal. *Id.*, ¶15.

Appellant’s notice of appeal does not state that “the agency’s order is not supported by reliable, probative, and substantial evidence and is not in accordance with law.” Accordingly, this Court lacks subject-matter jurisdiction to hear this appeal.

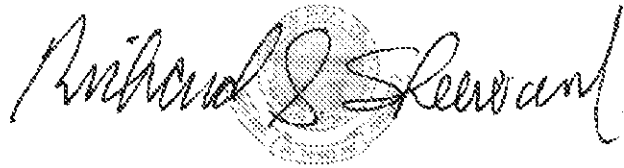
