**DECISION AND ENTRY AFFIRMING
DECISION OF UNEMPLOYMENT
COMPENSATION REVIEW
COMMISSION**

This matter is before the Court for decision of Appellants appeal of the decision of the Unemployment Compensation Review Commission which held that the hearing officer's conclusion that Appellant was terminated with just cause was appropriate under the facts of this case. This Court agrees.

Under R.C. 4141.29(D)(2)(a), an individual is ineligible for unemployment compensation benefits if the Review Commission determines that he or she was discharged from employment with just cause. The Court's review of the transcript of the hearing indicates that the hearing officer's conclusions were made upon facts reasonably supporting them adduced at hearing.

Because this Court has no authority to substitute its own judgment for that of the officer conducting the hearing to the extent that the administrative decision was not unlawful, unreasonable nor against the manifest weight of the evidence, and there being no indication from the record except that the decision is lawful, reasonable and supported by evidence, the decision of the Review

Commission, must be, and hereby is, affirmed. See, R. C. 4141.282; *Tzangas, Plakas & Mannos v. Adm.*, 73 Ohio St. 3d 694. (1995).
