FINAL JUDGMENT ENTRY

This case came on for consideration as a statutory unemployment appeal filed by Appellant Sarah Bishop (Bishop) on October 31, 2011 under R.C. 4141.282. Bishop appeals from the final *Decision* of the Unemployment Compensation Review Commission (UCRC) that held that Bishop was overpaid unemployment benefits in the amount of \$236.00 for reasons other than fraudulent misrepresentation pursuant to R.C. 4141.29(A)(4) and R.C. 4141.35(B).

After due consideration of the evidence in the certified record, the Court hereby affirms and modifies the *Decision* of the UCRC as follows. Specifically, the Court hereby affirms the *Decision* of the UCRC that Bishop was overpaid unemployment benefits in the total amount of \$236.00 for the benefit weeks ending May 28, 2011 and June 4, 2011 under R.C. 4141.35(B) because she was not available for and actively seeking suitable work under R.C. 4141.29(A)(4). However, the Court hereby modifies the *Decision* of the UCRC and finds that Bishop was available for and actively seeking suitable work under R.C. 4141.29(A)(4) and became re-eligible for unemployment benefits under R.C. 4141.29 as of the benefit week ending June 11, 2011.

Finally, the Court hereby ORDERS that no further penalty weeks or ineligibility period shall be imposed against Bishop with respect to this decision that she was overpaid benefits for reasons other than fraudulent misrepresentation in the total amount of \$236.00 for the benefit weeks ending May 28, 2011 and June 4, 2011 under R.C. 4141.35(B). Final judgment is hereby granted in favor of Appellee, Director, Ohio Department of Job and Family Services. Cost to Appellant.
