JUDGMENT ENTRY

This cause came to be heard on the administrative appeal filed by the Plaintiff/Appellant Steven W. Georgalas. Georgalas filed an administrative appeal following a decision by the Ohio Unemployment Compensation Review Commission. This Court has jurisdiction pursuant to R.C. 4141.282. The Court has reviewed the pleadings, briefs, record, exhibits and the relevant applicable law.

R.C. 4141.282 (H) provides: "The court shall hear the appeal on the certified record provided by the commission. If the court finds that the decision of the commission was unlawful, unreasonable, or against the manifest weight of the evidence, it shall reverse, vacate, or modify the decision, or remand the matter to the commission. Otherwise, the court shall affirm the decision of the commission."

On October 6, 2010, a telephonic hearing was held before the Unemployment Compensation Review Commission following an appeal by Blue Ribbon Rentals, Inc. of a decision approving unemployment compensation for Georgalas. Georgalas testified on his own behalf regarding the circumstances of his departure from employment with Blue Ribbon. William Wendell, Chris Rankin and Anthony Dieugenio testified on behalf of Blue Ribbon.

The Court has reviewed the transcript of the testimony from this hearing. The Court has also reviewed the written decision of the hearing officer from this October 6, 2010 hearing. The Court finds the decision is supported by the evidence. The Court further finds it is not unlawful or unreasonable.

Therefore, pursuant to R.C. 4141.282(H), the Court finds the decision of the commission is hereby affirmed.

IT IS SO ORDERED.


This is a final and appealable order and there is no just cause for delay.
