FINAL JUDGMENT ENTRY OF REMAND

This case came on for consideration as a statutory unemployment appeal that was filed by Appellant Adam Savett (Savett) on September 21, 2012 under R.C. 4141.282. Savett appeals from the *Decision* of the Unemployment Compensation Review Commission (UCRC) that held (among other things) that: 1) Savett was eligible for unemployment benefits under R.C. 4141.29 with respect to his mutually agreed separation from employment at Appellee Claims Compensation Bureau on September 23, 2011; and 2) Savett was ineligible for unemployment benefits in his allowed claim on the basis that he was not available for suitable work under R.C. 4141.29(A)(4)(a) after he filed his claim with Appellee ODJFS on January 10, 2012.

Accordingly, after due consideration of the evidence in the certified record, the Court hereby ORDERS that this case be REMANDED to the UCRC under R.C. 4141.282(H) for an in-person *de novo* evidentiary hearing to be held by the UCRC in the claim under R.C. 4141.281. Specifically, the Court hereby ORDERS that this case be REMANDED to the UCRC for an in-person *de novo* evidentiary hearing to be held by the UCRC under R.C. 4141.281 on the sole issue of whether Savett was ineligible for unemployment benefits in his otherwise allowed claim on the alleged basis that he was not available for suitable work under R.C. 4141.29(A)(4)(a) after he filed his claim with ODJFS on *January 10, 2012*. Costs to Appellant.
