This case came on for consideration as a statutory unemployment compensation appeal filed by Appellant Steve Bogas III (Bogas) on April 3, 2013 under R.C. 4141.282. Bogas appeals from the *Decisions* of the Ohio Unemployment Compensation Review Commission (UCRC) dated March 12, 2013 that held that Bogas was overpaid unemployment benefits under R.C. 4141.35(A) (See UCRC Docket No. C2012-029638, UCRC Docket No. C2012-029639, UCRC Docket No. C2012-029640, UCRC Docket No. C2012-029641 and UCRC Docket No. C2012-029643).

The Court hereby affirms and modifies the *Decisions* of the UCRC as follows. Specifically, the Court hereby affirms the *Decisions* of the UCRC that Bogas was overpaid unemployment benefits by ODJFS under R.C. 4141.35. However, the Court hereby modifies the *Decisions* of the UCRC and hereby finds that Bogas was overpaid unemployment benefits by ODJFS for reasons other than fraudulent misrepresentation pursuant to R.C. 4141.35(B) in UCRC Docket No. C2012-029638, UCRC Docket No. C2012-029649, UCRC Docket No. C2012-029641 and UCRC Docket No. C2012-029643.

Finally, the Court hereby modifies the *Decisions* of the UCRC and ORDERS that no further penalty weeks or ineligibility period shall be imposed against Bogas with respect to this decision that he was overpaid unemployment benefits for reasons other than fraudulent misrepresentation under R.C. 4141.35(B) in UCRC Docket No. C2012-029638, UCRC Docket No. C2012-029639, UCRC Docket No. C2012-029640, UCRC Docket No. C2012-029641 and UCRC Docket No. C2012-029643. Final judgment is hereby granted in favor of Appellee, Director, Ohio Department of Job and Family Services. Costs to Appellant
