## RULING ON DEFENDANT OHIO DEPARTMENT OF JOB AND FAMILY SERVICES' MOTION TO DISMISS

This case comes before the Court on a Motion to Dismiss and Memorandum filed December 20, 2013 by Defendant Ohio Department of Job and Family Services. Plaintiff Harry William Lott filed a pleading titled "Procedural Due Process" December 6, 2013 which asserts that he "applied for unemployment in 2011 and he never received a hearing for the denial." He seeks "punitive damages and back wages from the Job and Family. He subsequently filed a pleading December 19, 2013 titled "Summary Judgment; Vexatious Litigator; Jury Trial". As with other filings by this Plaintiff the pleadings are full of definitions, references to various State and Federal Statutes, and case law citations with sparse explanation of his claims and little or no factual support of any cause of action.

The Court finds that the Plaintiff has failed to state any claim upon which relief may be granted and further that this Court lacks jurisdiction over any claim for monetary damages against the Ohio Department of Jobs and Family Services. For these reasons, and supported by the Memorandum of Law filed by Defendant, the Motion to Dismiss is GRANTED. Plaintiff's Complaint is DISMISSED and all pending or related motions are rendered moot by the dismissal. Counsel for Defendant shall journalize. Costs assessed to Plaintiff.
