**DECISION AND ENTRY GRANTING MOTION TO DISMISS
OF APPELLEE DIRECTOR, OHIO DEPARTMENT OF JOB & FAMILY SERVICES,
Filed July 2, 2014**

LYNCH, J.

This matter is before the Court upon the motion of Appellee, Director, Ohio Department of Job and Family Services (“ODJFS”) for an order dismissing the claims of Appellant Michael Mojzer (“Appellant”), filed July 2, 2014. The motion is unopposed.

In its motion, ODJFS argues Appellant’s unemployment compensation appeal must be dismissed for lack of subject matter jurisdiction. Specifically, ODJFS asserts that Appellant’s failure to comply with the requirements of R.C. 4141.282 that he (1) timely perfect his appeal, and (2) name all interested parties as appellees deprives this Court of jurisdiction over the appeal.

Upon review, the Court finds the motion to dismiss of ODJFS well taken. Accordingly, the Court **GRANTS** the motion and the appeal of Appellant Michael Mojzer is hereby **DISMISSED** in its entirety, with prejudice.
