This case came on for consideration as a statutory unemployment appeal that was filed by Appellant Bill Bail (Bail) under R.C. 4141.282. Bail appeals from the final *Decision* of the Ohio Unemployment Compensation Review Commission (UCRC) that held that the unemployment benefits payable to Bail in his allowed claim after his separation from Appellee AT&T Services, Inc. (AT&T), must be reduced on the basis of *separation pay* pursuant to R.C. 4141.31(A)(4).

According to the evidence in the certified record of the UCRC, Bail was employed by AT&T from November 7, 1988 until February 1, 2014.

On March 9, 2014, Bail filed a claim for unemployment benefits with Appellee, Director, Ohio Department of Job and Family Services (ODJFS). On March 26, 2014, ODJFS issued a *Determination of Benefits* that allowed the claim on the basis that Bail was laid off for lack of work under R.C. 4141.29 but reduced the benefits payable to Bail on the basis of separation pay from AT&T (\$58,800.00) under R.C. 4141.31(A)(4). On April 7, 2014, Bail filed an appeal of the *ODJFS Determination of Benefits* dated March 26, 2014.

On April 21, 2014, ODJFS issued a *Redetermination of Benefits* that affirmed the *ODJFS Determination of Benefits* dated March 26, 2014. On April 21, 2014, Bail filed an appeal of the *ODJFS Redetermination of Benefits* dated April 21, 2014. On April 22, 2014, ODJFS transferred jurisdiction of the Bail claim on appeal to the UCRC pursuant to R.C. 4141.281.

On May 8, 2014, an evidentiary hearing was held by a hearing officer of the UCRC in the Bail claim under R.C. 4141.281. According to the evidence in the certified record of the UCRC, Bail appeared and testified at the hearing that was held by the UCRC on May 8, 2014 and AT&T failed to appear at the hearing held by the UCRC on May 8, 2014.

On May 16, 2014, a *Decision* was issued by the hearing officer of the UCRC that affirmed the ODJFS Redetermination of Benefits dated April 21, 2014 and allowed the claim on the basis that Bail was laid off for lack of work under R.C. 4141.29 but reduced the benefits payable to Bail on the basis of his separation pay from AT&T (\$58,800.00) under R.C. 4141.31(A)(4).

On May 27, 2014, Bail filed a Request for Review of the Decision of the hearing officer of the UCRC dated May 16, 2014 under R.C. 4141.281. In the Request for Review that was filed by Bail on May 27, 2014, Bail cited to (and attached) a letter from Equifax (on behalf of AT&T) dated May 23, 2014 that affirms that the separation pay was allocated by AT&T to the last day worked of Bail (See Request for Review filed on May 27, 2014).

On June 25, 2014, a final Decision was issued by the UCRC that disallowed the Request for Review filed by Bail on May 27, 2014 under R.C. 4141.281(C)(5). On July 25, 2014, Bail filed a Notice of Appeal in the Wayne County Court of Common Pleas under R.C. 4141.282.

Accordingly, after due consideration of the evidence in the certified record of the UCRC, the Court hereby ORDERS that this case be REMANDED to the UCRC pursuant to R.C. 4141.282(H) for a de novo evidentiary hearing to be held by the UCRC in the claim under R.C. 4141.281 on the issue of whether the unemployment benefits payable to Bail in his allowed claim should be reduced on the basis of his separation pay under R.C. 4141.31(A)(4) (See letter from Equifax (on behalf of AT&T) dated May 23, 2014 that affirms that the separation pay was allocated by AT&T to the last day worked of Bail (See Request for Review filed on May 27, 2014).
