### **Decision and Entry**

Rendered this 20th day of April, 2015

This matter is before the Court upon the Motion to Dismiss, filed April 13, 2015, by the Director of Ohio Department of Job and Family Services (hereinafter "ODJFS"). Plaintiff-Appellant Otelia E. Simmons (hereinafter "Simmons") filed a response on April 14, 2015. The issue is now ripe for determination.

#### STATEMENT OF FACTS

On January 22, 2015, Simmons filed an appeal of a decision disallowing further review of the denial of her application for unemployment compensation benefits. Simmons named only the State of Ohio Unemployment Compensation Review Commission as a Defendant-Appellee. ODJFS now moves the Court to dismiss Simmons' appeal, arguing that this Court lacks jurisdiction. Simmons responded requesting that the Court deny the motion and expressing a desire to present her case to the Court.<sup>1</sup>

#### LAW AND ANALYSIS

R.C. § 4141.282 provides the requirements for the appeal process from decisions of the State of Ohio Unemployment Compensation Review Commission. The statute states, in pertinent part:

#### (D) Interested Parties

The commission shall provide on its final decision the names and addresses of all interested parties. The appellant shall name all interested parties as appellees in the notice of appeal. The director of job and family services is always an interested party and shall be named as an appellee in the notice of appeal.

If any of the requirements of R.C. § 4141.282 are not met, the Court is without jurisdiction to consider an appeal. *In re Claim of King*, 62 Ohio St.2d 87, 88, 403 N.E.2d 200 (1980).

#### **CONCLUSION**

Accordingly, the Court lacks jurisdiction to hear the instant matter. ODJFS's Motion to Dismiss filed on April 13, 2015, is hereby **GRANTED**. This matter is **DISMISSED**. Costs to Appellant.
