DECISION AND ENTRY GRANTING MOTION TO DISMISS FOR LACK OF JURISDICTION Filed July 7, 2015

LYNCH, J.

This matter is before the Court upon the motion of ODJFS, Director, Ohio Department of Job & Family Services ("ODJFS") for an order dismissing the claims of Appellant Charlene R. Burt ("Appellant"), filed July 7, 2015. The motion is unopposed.

In its motion, ODJFS argues Appellant's unemployment compensation appeal must be dismissed for lack of subject matter jurisdiction for (1) failure to comply with the requirements of R.C. 4141.282(D) that all interested parties be named in the notice of appeal; and (2) failure to timely perfect her appeal pursuant to R.C. 4141.282(A). Specifically, ODJFS asserts that Appellant failed to perfect her appeal within the thirty day appeal period specified by R.C. 4141.282(A) and failed to name both the Director, Ohio Department of Job & Family services and the employer as interested parties, thereby depriving this Court of jurisdiction over the appeal.

Upon review, the Court finds the motion to dismiss of ODJFS well taken on both bases because the notice of appeal was filed well past the thirty-day time period

provided for by the statute and because Appellant failed to name ODJFS as an interested party. Although a review of the Complaint and Clerk's docket shows that the employer, Variety Stores, Inc. was named, the failure to name ODJFS suffices to deprive the Court of jurisdiction. See *Sydenstricker v. Donato's Pizzeria*, 11th Dist. No. 2009-L-149, 2010-Ohio-2953 (followed by *Mattice v. Ohio Dept. of Job & Family Svcs.*, 2nd Dist. No. 2718, 2013-Ohio-3941; *Dikong v. Ohio Supports, Inc.*, 2013-Ohio-33; 985 N.E.2d 940); see also R.C. 4141.282(A). Accordingly, the Court **GRANTS** the motion and the appeal of Appellant Charlene R. Burt is hereby **DISMISSED** in its entirety, with prejudice.
