DECISION AND ENTRY GRANTING MOTION TO DISMISS FOR LACK OF SUBJECT MATTERJURISDICTION Filed July 24, 2015

LYNCH, J.

This matter is before the Court upon the motion of ODJFS, Director, Ohio Department of Job & Family Services ("ODJFS") for an order dismissing the claims of Appellant William E. Gibson ("Appellant"), filed July 24, 2015. The motion is unopposed.

In its motion, ODJFS argues Appellant's unemployment compensation tax appeal must be dismissed for lack of subject matter jurisdiction for failure to comply with the requirements of R.C. 4141.26(D)(2) to timely perfect his appeal and failure to provide a proff of filing with the Unemployment Compensation Review Commission. Further, ODJFS argues that because the appeal was drafted and signed by neither the Appellant himself nor a licensed attorney appearing on his behalf, the pleading must be stricken in any event.

Upon review, the Court finds the motion to dismiss of ODJFS well taken on both bases. The appeal was filed late. See R.C. 4141.26(D)(2). Moreover, even if it had not

been filed late, the appeal and proceeding must be stricken and dismissed because the person who prepared and signed it is not an attorney licensed to practice law in the State of Ohio. See Bank of New York v. Miller, 185 Ohio App.3d 163 (2009). Accordingly, the Court **GRANTS** the motion and the appeal of Appellant William E. Gibson is hereby **DISMISSED** in its entirety, with prejudice.
