This matter is before the Court upon the Motion to Dismiss, filed September 1, 2015, by the Director of Ohio Department of Job and Family Services (hereinafter “ODJFS”). Plaintiff-Appellant Wanda Stanley (hereinafter “Stanley”) has not filed a response.

STATEMENT OF FACTS

On August 20, 2015, Stanley filed an appeal of a decision disallowing further review of the denial of her application for unemployment compensation benefits. The Ohio Unemployment Compensation Review Commission listed both ODJFS and Stanley’s employer, System Design Advantage, LLC, as interested parties. Stanley named only ODJFS as Defendant-Appellee. As a result, ODJFS filed the instant motion, arguing that this Court has no jurisdiction over this appeal.

LAW AND ANALYSIS

R.C. § 4141.282 provides the requirements for the appeal process from decisions of the Commission. The statute states, in pertinent part:

(D) Interested Parties

The commission shall provide on its final decision the names and addresses of all interested parties. The appellant shall name all interested parties as appellees in the notice of appeal. The director of job and family services is always an interested party and shall be named as an appellee in the notice of appeal.

If any of the requirements of R.C. § 4141.282 are not met, the Court is without jurisdiction to consider an appeal. *In re Claim of King*, 62 Ohio St.2d 87, 88, 403 N.E.2d 200 (1980).

CONCLUSION

Accordingly, the Court lacks jurisdiction to hear the instant matter. ODJFS's Motion to Dismiss filed on September 1, 2015, is hereby **GRANTED**. This matter is **DISMISSED**.
