This case arises as a statutory unemployment appeal filed by Appellant Cynthia Sarady (Sarady) on July 29, 2015 under R.C. 4141.282. Sarady filed this appeal from the final *Decision* of the Ohio Unemployment Compensation Review Commission (UCRC) dated July 1, 2015.

Pursuant to R.C. 4141.282(G), the parties in a statutory unemployment appeal filed under R.C. 4141.282 are legally required to comply with the briefing schedule to be established by the court of common pleas as follows:

R.C. 4141.282(G) // COURT BRIEFING SCHEDULES

The court shall provide for the filing of briefs by the parties, whether by local rule, scheduling order, or otherwise.

According the case docket of the Clerk of Court in this case, the certified record of the UCRC was duly filed in this case on September 2, 2015 as required by R.C. 4141.282.

On December 1, 2015, a *Briefing Schedule Order* was filed by the Court in this case pursuant R.C. 4141.282(G) whereby Sarady was ordered by the Court to file the *Brief of Appellant* no later than December 31, 2015 as required by R.C. 4141.282(G).

However, according to the docket of the Clerk of Court in this case, the Court hereby finds that Sarady failed to file the *Brief of Appellant* by December 31, 2015 as ordered by the Court in the *Briefing Schedule Order* filed on December 1, 2015 in violation of R.C. 4141.282(G).

Based upon the foregoing, the Court hereby ORDERS that this case be DISMISSED for failure to prosecute under R.C. 4141.282 because Sarady failed to file the *Brief of Appellant* in the case by December 31, 2015 as ordered by the Court in the *Briefing Schedule Order* that was filed on December 1, 2015 in violation of R.C. 4141.282(G). Costs to Appellant.
