This is an administrative appeal of a February 3, 2016 Unemployment Compensation Review Commission decision that it had no jurisdiction to review a reconsidered decision of the Director, ODJFS because the application for review was not timely filed. The envelope in which the appeal was sent to the Review Commission bore no postmark, and, pursuant to R.C. 4141.281 (D) (1), must have been received by the end of the fifth day following the last day for appeal. The appeal arrived one day late, and was therefore untimely. The Review Commission properly determined that it had no jurisdiction to review the appeal. Accordingly, this Court must dismiss the appeal for failure to exhaust administrative remedies.

Appellee's Motion to Dismiss is well-taken. This appeal shall be and is hereby DISMISSED, with prejudice to refiling.


