**DECISION AND ENTRY**

**O’DONNELL, J.,**

On May 25, 2017, Appellee, Director, Ohio Department of Job and Family Services, filed a “MOTION TO DISMISS FOR FAILURE TO PROSECUTE” pursuant to Appellant’s failure to file a brief and prosecute the case herein. Civ. R. 41(B)(1). Appellant, Kaiser W. Jones, III, did not file a memorandum in opposition.

Appellee asserts that Appellant, pursuant to R.C. 4141.282, filed its notice of appeal on March 3, 2017, from a decision of the Ohio Unemployment Compensation Review Commission. The record demonstrates that as set forth in the Original Case Schedule issued by the Franklin County Clerk of Courts, Appellant’s brief was due on May 12, 2017. The record demonstrates that Appellant has failed to file a brief and has not sought leave for an extension of time.

Accordingly, pursuant to Civ. R. 41(B)(1), Appellee's May 25, 2017 motion to dismiss is hereby **GRANTED**.
