ORDER GRANTING DEFENDANT'S MOTION TO DISMISS

This matter comes before the Court on Defendant/Appellee Ohio Department of Job and Family Services' June 5, 2017 Motion to Dismiss, to which Plaintiff did not respond. Defendant rightly highlights that the Notice of Appeal was filed by Chad Diggs, who is not an attorney, on behalf of a limited liability company. Ohio law is clear that individuals who are not licensed attorneys may not engage in the practice of law, much less represent a corporate entity¹ and that corporations cannot maintain litigation *in propria persona*.² Thus the Notice of Appeal is a nullity. Because the time to perfect the appeal here has lapsed per R.C. 4141.282(A), the Motion is **GRANTED** and the instant appeal is hereby *dismissed*.
