The Ohio Attorney General's Bureau of Criminal Investigation (BCI) and the Stark County Coroner's Office are seeking help in identifying male human remains discovered on Dec. 22, 2001 at 2931 Trump Ave SE in Canton Ohio. The remains were completely skeletonized when discovered and may have been at that location for multiple years. The decedent is believed to be a Black male between 21 and 44 years old. Additional details such as weight, hair color and eye color are unknown.

BCI's forensic artist completed a facial reconstruction and worked with the Office of Academic Affairs Digital Learning (OAA DL) and the Advanced Computing Center for the Arts and Design (ACCAD) at the Ohio State University to generate additional digital images of what the individual may have looked like. Item's such as hair style are estimations to complete the image and should not be considered as significant markers for identification.

DNA analysis has been completed and is on file for this individual. Anyone with information is asked to call the Stark County Sheriff's Office at 330-430-3823 or 330-451-3937.

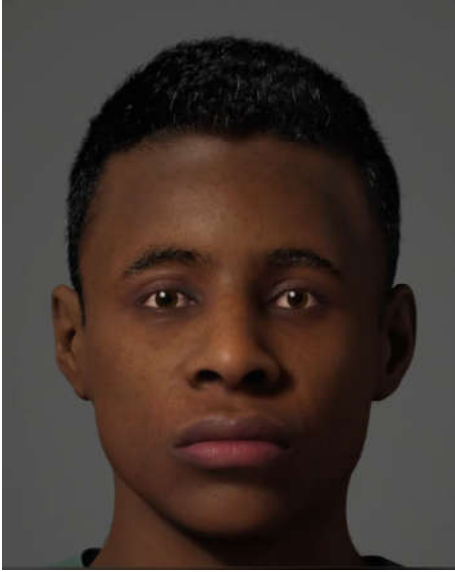

(No Aging, No Facial Hair, Short Hair)



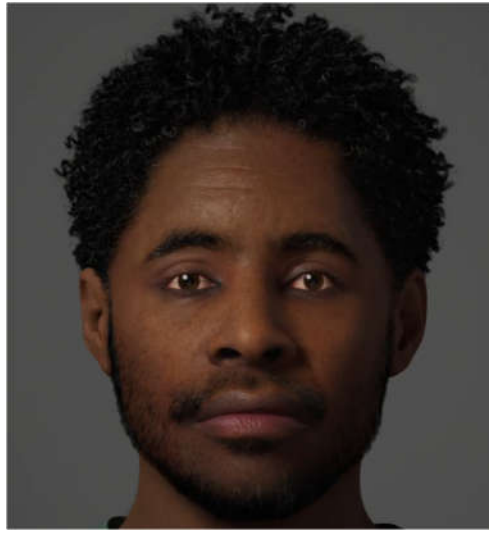
(Some Aging, Some Facial Hair, Short Hair)

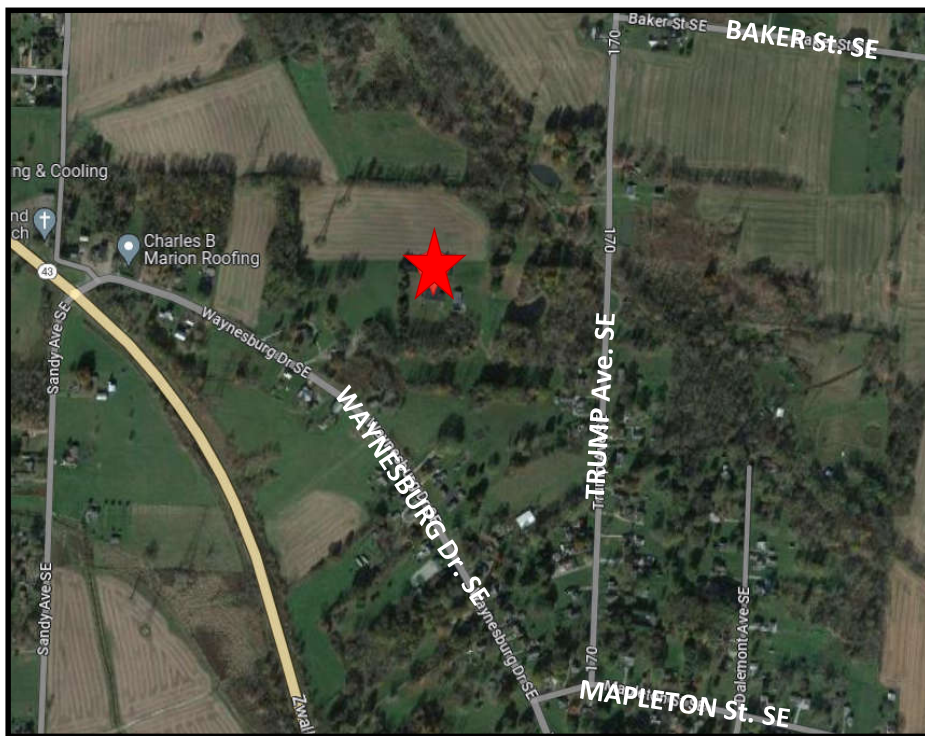
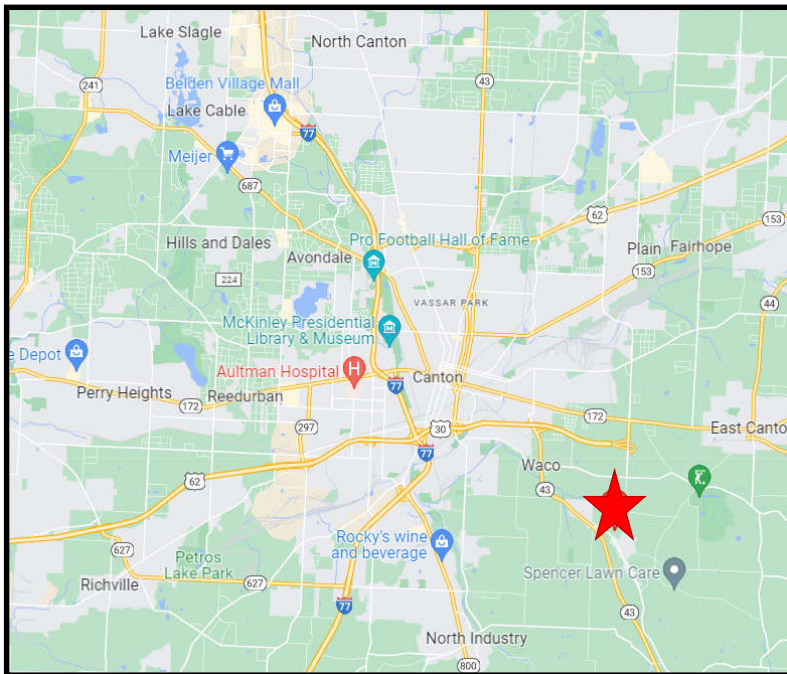
