ORDER

This matter came to the Court on the Attorney General's motion for default judgment against Defendants Darien E. Smith & TEEN USA. Service of process was made on Defendants on April 1, 2014. Defendants have failed to answer Plaintiff's Complaint. Based on the foregoing, the Court finds that the Attorney General has presented sufficient grounds to grant the relief requested.

IT IS HEREBY ORDERED:

1. The Court grants the Attorney General's request for a civil penalty of liquidated damages for an amount of \$320,000 in accordance with the previously agreed-upon Assurance of Discontinuance signed by Darien E. Smith;
2. Defendants are permanently enjoined from soliciting in the state of Ohio for charitable purposes or on behalf of any charitable organization as stated in the terms of the previously agreed-upon Assurance of Discontinuance;

3. The Court grants relief to enforce all terms of the previously agreed-upon Assurance of Discontinuance;
4. The Court grants the Attorney General's request for joint and several liability against Defendants; and
5. The Court grants the Attorney General other relief as the Court deems proper and necessary.
