The Plain Dealer Video Recordings / Photos from OCIC

Summary

On January 02, 2013 S/A Brenda McNeely reviewed video recordings titled SI-18-12-82-1493 Clarified Images / PDF's and 3 videos titled SI-18-12-82-1493 Video Presentation from The Ohio Organized Crime Investigations Commission Forensic Analyst Bradley Barkhurst, along with the return of 4 video recordings from the exterior of The Plain Dealer building, 1801 Superior Avenue East, Cleveland, Ohio 44114. In addition, 14 photographs were included.

Details

The DVD's titled Clarified Images / PDF's appeared to be 14 images from the video recordings of The Plain Dealer, identified previously as camera #13 and camera #37. These images appear consistent with the 14 photographs that were enclosed. These images were enlarged and cropped to clarify if Officer John Jordan exited his vehicle at the time of the traffic stop.

The DVD's titled video presentation appeared to be 8 separate segments including a video format of the 14 still images / the raw video of camera recordings previously titled camera #13 and camera #37 and enhanced video as follows:

Segment #1: Still images with Forevid filter and clear I.D. Still Image #80 reflects an image consistent with Officer Jordan exiting his vehicle and still image #276 reflects the vehicle consistent with the vehicle driven by Timothy Russell leaving the traffic stop and still image #298 is consistent with Officer Jordan getting back into his vehicle.

Segment #2: Still images repeated with Forevid filters and clear I.D. applied but now is zoomed in.

Segment #7: Video segment camera #37 – raw video

Segment #8: Video segment camera #13 – raw video, including 1 % motion effect
