Summary

SA Warner and SA Lee Lerussi spoke with Ms. Stephanie L. Morley an Administrator at McGregor Nursing Facility at 14900 Private Drive in East Cleveland. The McGregor Nursing Facility overlooks and can be seen from Heritage Middle School in East Cleveland. Ms. Morley stated the cameras on the exterior of the building are in a fixed position on the property and that they did not capture the officer involved shooting.

SA Warner and Lerussi met with Officer Bobby Davis of the East Cleveland Public Library. Officer Davis advised that he would identify cameras on the Library that would display Euclid Avenue and would determine if there is any video related to the time frame of the pursuit. Officer Davis was able to provide video footage from the pursuit. SA Warner collected the videos and submitted them as evidence.

SA Warner and SA David Pauley met with Mr. Ted Lichko of United Furniture at 13829 Euclid Ave in East Cleveland, Ohio. Mr. Lichko advised that his camera system was not functioning properly on the date of the pursuit and did not capture any video.

SA's Warner and Pauley met with Mr. Hasann Farrah, an employee of the Shell station at 13441 Euclid Avenue in East Cleveland, Ohio. Mr. Farrah provided video footage from the business that displays Euclid Avenue and displays the pursuit. The footage was copied to Compact Disk and later submitted as evidence.
