**12/06/2012 INTERVIEW OF JOHN R. RYFA**

**Summary**

Pursuant to the ongoing Cleveland Police Department officer involved shooting of Timothy Russell and Malissa Williams on November 29, 2012, Ohio Bureau of Criminal Investigation Special Agents Kevin Cooper and Perry Roeser interviewed John Ryfa, General Superintendent for Turner Construction Company, on December 6, 2012 at 1030 hours in front of the Cleveland City Administration Building located at 601 Lakeside Ave., Cleveland, Ohio 44114.

**Details**

Pursuant to the ongoing Cleveland Police Department officer involved shooting of Timothy Russell and Malissa Williams on November 29, 2012, Ohio Bureau of Criminal Investigations Special Agents Kevin Cooper and Perry Roeser interviewed John Ryfa, General Superintendent for Turner Construction Company, on December 6, 2012 at 1030 hours in front of the Cleveland City Administration Building located at 601 Lakeside Ave., Cleveland, Ohio 44114.

Ryfa was questioned concerning the construction schedules of the evening of November 29, 2012. Ryfa provided the following statements.

Ryfa stated that all construction occurs at the construction site contained in the block of St. Clair, Ontario, Lakeside and West Third between the hours of 0700 and 1800 hours. Ryfa stated the only exception would be if a concrete pour occurred. Ryfa stated a concrete pour begins just prior to midnight and lasts until 0100 or 0300 hours. Ryfa stated construction pours only occur on Tuesdays. Ryfa stated no concrete pours occurred on November 29, 2012.

Ryfa stated he would check his records to verify there were no unusual situations with contractor schedules on Thursday, November 29, 2012 during the hours of 2200 to 2300 hours.
