**DECEMBER 10, 2012 – AREA CANVASSING FOR SURVEILLANCE VIDEO SYSTEMS**

**Summary**

Special Agent Richard Warner canvassed the area of pursuit route to obtain copies of video surveillance related to an officer involved shooting.

**Details**

December 10, 2012

0840 hours

SA Warner spoke with Sergeant Dan Schemmel of Case Western Reserve Police Department to obtain video footage of the pursuit that traveled on Wade Park Ave to E. 118<sup>th</sup> Street to Euclid Avenue on November 29, 2012 between 2240 hours and 2300 hours. Sergeant Schemmel advised that, he would have the video available later in the afternoon.

1150 hours

SA Warner met with Mr. John Egan of Cleveland Public Power at 1735 Street Clair Street in Cleveland, Ohio. Mr. Egan advised that the cameras on the property are non-functioning.

1205 hours

SA Warner met with Mr. Sam Barbone, Branch Manager, of Brinks Cleveland Coin. Mr. Barbone was asked to provide video from the business front of 1617 St. Clair Avenue on November 29, 2012 during the hours of 2220 hours to 2240 hours. Mr. Barbone advised that he would contact SA Warner when the video was available.

1231 hours

SA Warner met with Mr. Ben Yeboah to determine if the video camera in the front of 1530 St. Clair Avenue would have captured any traffic on St. Clair Avenue. Mr. Yeboah displayed the video surveillance to SA Warner and found that it does not capture any portions of St. Clair Avenue

1240 hours

SA Warner met with Mr. Mark Brajdich to determine if the video cameras in the front of 1628 St. Clair Avenue would have captured any traffic on St. Clair Avenue. Mr. Brajdich advised that his cameras would capture portions of St. Clair Avenue traffic. However, the video only goes as far back as December 2, 2012. All previous data had been over written.

1430 hours

SA Warner met with Mr. John Grzincic, Building Manager, of Matrix Reality Group 1625 Rockwell Drive in Cleveland, Ohio. Mr. Grzincic displayed his camera videos which were not capturing any portions of St. Clair Avenue.

SA Warner received a phone call from Mr. Michael T. Velkoff, Security Director, of Stark Enterprises. SA Warner asked Mr. Velkoff if the camera atop of 1350 W. 3<sup>rd</sup> Street in Cleveland, Ohio, would have captured any video of St. Clair Avenue and W. 3<sup>rd</sup> Street. Mr. Velkoff indicated that the camera in question does not.

1450 hours

SA Warner met with Mr. James Leonard of MCPc located at 1401 East 18<sup>th</sup> Street in Cleveland, Ohio. Mr. Leonard assisted SA Warner in obtaining video footage of St. Clair Avenue and E. 18<sup>th</sup> Street. SA Warner submitted the video footage as evidence.

1500 hours

SA Warner met with Captain Felicia Gauriluta, Security for The Plain Dealer. Captain Gauriluta was asked to locate any video footage of E. 18<sup>th</sup> Street between St. Clair Avenue and Superior Avenue. Captain Gauriluta advised that she would contact SA Warner if any video footage was located for the time period on November 29, 2012 between 2220 hours and 2240 hours.

1527 hours

SA Warner secured video footage from Mr. Jim Mix, Paralegal for the Cleveland Metropolitan School District. Mr. Mix provided video footage from Max Hayes High School, 4600 Detroit Avenue, Cleveland, Ohio and Wade Park School 7600 Wade Park Avenue. SA Warner submitted the video footage as evidence.

1630 hours

SA Warner met with Mr. Dale Schantz, Manager, of Crazy Horse Saloon 1438 St. Clair Avenue. Mr. Schantz displayed video of a camera that would capture St. Clair Avenue. Mr. Schantz advised that the video only goes back to six days and that November 29, 2012 footage had already been overwritten.
