12/12/12 Review of Surveillance Video; Conveyor Caster, 3501 Detroit Avenue


Summary

On December 12, 2012 SA Lerussi was assigned to assist in the investigation of an Officer Involved Shooting and Police Pursuit by review of surveillance Video obtained from various locations and sources along the reported route the pursuit traveled. The assignment was to review the video files and to provide a summary of any activities observed relating to the pursuit and or shooting.

Details

On December 12, 2012 SA Lerussi was assigned to assist in the investigation of an Officer Involved Shooting and Police Pursuit by review of surveillance Video obtained from various locations and sources along the reported route the pursuit traveled. The assignment was to review the video files and to provide a summary of any activities observed relating to the pursuit and/or shooting.

The video reviewed can be identified as item 23 from the BCI&I CCU lab submission (Exhibit #24), and reports to be from a surveillance system located at the Conveyor and Caster offices located at 3501 Detroit Avenue, Cleveland, Ohio. The person who prepared the CD-R was Brian Harrington (DOB 8.27.1983.) It can be noted that the system in use is not displaying the correct date and time, the surveillance system displays the date and time of 2012-12-05; 04:45:39 and the computer running the system displays the date and time of 2012-12-05; 12:41 PM the video system is 7 hours; 55 min; 21 seconds behind the actual date and time. The date and time range requested for review was from November 29, 2012 from 2230 until 2300. The adjusted time range was calculated to be 14:34:39 until 15:04:39. The CD contains 109 files, 108 of which are video files. There are three (3) separate cameras that captured events; Camera Number 3, Camera Number 8 and Camera Number 11.

Camera 11: includes the time period 2012-11-29; 14:49:11 to 15:59:37. Therefore the supplied recording for this camera does not include approximately 15 min of the beginning of the requested time frame. This camera appears to face Detroit Avenue, pointing away from the downtown area and is of high quality and well lighted.

15:37:27 A black and white patrol car is observed traveling left to right on Detroit without lights activated.

15:34:41 A female walks left to right along the sidewalk of Detroit.

15:35:31 A black and white patrol car is observed traveling right to left on the Cleveland Memorial Shoreway which runs parallel to Detroit at this point.

15:40:50 A black and white patrol car is observed traveling left to right without lights on Detroit.

Camera 8: includes the time period of 2012-11-29; 14:02:52 until 15:56:21. The camera is facing Detroit Avenue, towards the city and the exit/entrance ramp of the Cleveland Memorial Shoreway is seen in the background.

14:44:07 Two cars are seen traveling left to right slowly.

14:44:36 A black and white patrol car is observed traveling left to right with lights activated. There is no vehicle observed ahead of the patrol car except those noted above.

15:11:56 A black and white patrol car is observed traveling left to right without lights activated.

15:32:30 A black and white patrol car is observed traveling left to right without lights activated.

Camera 3: includes the time period of 2012-11-29; 14:00:00 until 15:56:21. It appears the camera also faces Detroit Avenue, away from the city, and the Cleveland Memorial Shoreway appears in the extreme background.

14:24:23 white police car with stripe on side travels right to left on Detroit Avenue without lights activated.

14:28:33 A black and white patrol car travels left to right on Detroit Avenue.

14:31:02 2 cars (no markings) travel left to right on Detroit Avenue slow to turn left at edge of video screen and the rear most car activates either hazard lights or 4-way flashers.

14:36:47 A black and white patrol car travels left to right with lights activated.

14:38:50 A unmarked/civilian car traveling left to right on Detroit Avenue slows and pulls towards curb, an SUV traveling right to left; and an unmarked/civilian car traveling right to left on Detroit Avenue.

14:38:58 2 marked patrol cars travel right to left on Detroit Avenue with lights activated.

14:39:15 3 persons walking on sidewalk adjacent to Detroit Avenue.

14:39:38 Civilian car traveling left to right slows, approaching patrol car travels right to left with lights activated. 2 persons standing on curb at edge of screen. 1 patrol car with lights activated travels right to left.

14:41:57 4 total patrol cars with lights activated travel right to left.

14:41:32 A patrol car with lights activated travels right to left.

15:40:52 A marked black and white patrol car travels right to left without lights.
