DECEMBER 17, 2012: REVIEW OF HERITAGE SCHOOL SURVEILLANCE 11-29-2012 VIDEO CD



Summary

Around December 3, 2012, a video CD had been turned over to S/A Mark Kollar at the BCI Richfield Office, 4055 Highlander Parkway, Richfield, Ohio, 44286. The video CD originated from the East Cleveland City Schools Superintendent, Myrna Loy Corley (1843 Stanwood Road, East Cleveland, OH 44112; Ph. 216-268-6580). The video CD contained surveillance footage from two (2) stationary video cameras located inside Heritage Middle School (14410 Terrace Road, East Cleveland, OH 44112, Ph.: 216-268-6610). The video cd captures surveillance from 11-29-2012 starting at 21:00:00 hrs. through 11-30-2012 at 10:30:59. On December 17, 2012, S/A Jean-Philippe Rigaud reviewed the video CD for possible evidence captured on the video cameras regarding case SI-18-12-82-1493.

File labeled Cam01 (2012_11_29 21_00_00-2012_11_30 10_31_00)a is 455MB. It provides video surveillance of the foyer and double glass doors entrance facing the northeast parking lot of the middle school. S/A Rigaud made the following observations of this file:

- No video exists which provides actual footage of the alleged pursuit and shooting occurring in the northeast parking lot.
- At 22:59 hrs, blue flashing lights reflect in the glass doorway
- At 00:41:00 hrs. of 11-30-2012, interior lights are switched on and approximately sixteen (16) uniformed officers enter through this door and foyer. Another group of approximately nine (9) primarily plain-clothed subjects then walk in at 00:43:00 hrs. Four (4) other subjects then enter around 00:44:30 hrs, two of whom appearing to be Cleveland Police Patrolmen's Association President, Jeff Follmer, and Vice-President, Steve Kinias.
- Video continues until 00:44:55 hrs, 11-30-2012. The recording then skips to 01:55:50 hrs, 11-30-2012.
- Video continues until 01:56:09 hrs. , 11-30-2012. The recording then skips to 02:35:55 hrs. and records up to 03:02:00 hrs. The recording then skips to 03:18:00 hrs.
- The above-listed video segments capture subjects walking around the foyer, conversing to other subjects as well as using their cell phones. No other significant activity is observed.
- At 04:02:47 subjects walk out this northeast entrance and the building lights are turned off. A male subject appears to lock the foyer door.

File labeled Cam01 (21_00_00-10_31_00) is 271MB. It provides video surveillance from an interior space on the second level of the middle school. The camera is facing a large picture window with a railing. This window provides northeast view of Terrace Road at the intersection of Marloes Avenue and Rosemont Road. S/A Rigaud made the following observations of this file:

- No video exists of the investigated shooting occurring in the northeast parking lot.
- At 22:58:35 hrs, steady streams of red and blue flashing lights are seen at the intersection of Marloes and Euclid Avenues. The lights are moving eastbound on Euclid Avenue.
- Between 22:58:47 and 23:01 hrs, police vehicles with illumined overhead lights travel from Rosemont Road, turning east onto Terrace Road.
- At 23:09 hrs, what appears to be a fire truck with illumined overheads travels from Marloes Avenue to Terrace Road. It then heads eastbound on Terrace Road. A second fire truck travels from Rosemont Road to Terrace Road and heads eastbound at 23:10 hrs.
- Gaps in the recording appear throughout the CD during most hours prior to 06:00 of 11-30-2012. These gaps show no obvious pattern to their frequency and vary in length.
