On December 12th, 2012 Detective Sergeant Scott Gardner with the East Cleveland Police Department, Detective Sergeant Clifford Pinkney (Cuyahoga County Sheriff's Office), and Detective Jim Mackey (Cuyahoga County Sheriff's Office) went to the Cleveland Branch of the Federal Bureau of Investigation at 1501 Lakeside Avenue, Cleveland, Ohio 44114. There we met with Special Agent Christopher Garnett who provided Detectives with a telephone number of (216) 522-1400.

A team of Agents had been flown in from Quantico, Virginia to perform a "Spherical Video" capture of the pursuit route. One recording was done during the day and one recording was done during the evening.


During the day time route it took approximately 1 hour and 4 minutes and for the night route it took 1 hour and 7 minutes.


Agents were thanked for their time.
