**12/19/2012 REVIEW OF CASE WESTERN RESERVE UNIVERSITY
 SURVEILLANCE VIDEO CAMERA DVD**

Summary


On December 19, 2012 S/A David G. Horn was requested to review a CD from Case Western Reserve University surveillance cameras regarding a chase of a suspect in Cleveland, OH on November 29, 2012.

Details

On December 19, 2012 S/A Horn was given a CD from S/A Mark Kollar that needed reviewed. The CD contained surveillance from three separate camera views. The CD was labeled Case Western Reserve University, Along E 118th St and Euclid. Three separate camera views were on the single CD.

The first video S/A Horn reviewed was labeled CPD East Field.

The video showed a two way road in a residential area with the roadway lit by street lights. The camera was at an angle on top of a building. It showed a vehicle traveling towards the camera view at 0:35 seconds into the video. The vehicle was being followed by 12 marked and unmarked vehicles with emergency lights activated. After the 12 vehicles passed, there was a 6- to 8-second gap with 5 more vehicles with emergency lights activated, that passed the cameras view. Two more vehicles, emergency lights activated, came into the cameras view at 1:38 seconds from the start of the video.

The video concluded with a marked patrol car going in the opposite directions.

The second video viewed by S/A Horn was labeled E 118th.

This camera was on top of a building, viewing the street below. The video showed a vehicle being followed by twelve vehicles with emergency lights activated at 0:32 seconds from the start. Four vehicles with emergency lights activated passed at 0:56 seconds from the start. Two more patrol cars passed the camera at 1:30 seconds into the video. One patrol car with no emergency lights activated passed the surveillance video at 2:54 seconds into the video.

S/A Horn viewed the third video labeled E 117th.

The camera also on top of a building, showed video showed 19 vehicles passing the surveillance camera at 0:30 seconds from the start. Eighteen (18) vehicles with emergency lights were following one (1) vehicle.

At 2:35 seconds into the video a vehicle with emergency lights activated stops at the intersection of two streets, while four vehicles passed from the right to left on the cameras view. The stopped vehicle then pull behind followed the pursuing vehicles.

Special Agent Horn concluded the review of the disk from Case Western Reserve University, Along E118th St and Euclid. The DVD was turned over as Exhibit #49 for this case file.
