12/19/2012 REVIEW OF SURVEILLANCE VIDEO FROM DOLLAR GENERAL

Summary


On December 12, 2012 SA Lerussi was assigned to assist in the investigation of an Officer Involved Shooting and Police Pursuit by review of surveillance video obtained from various locations and sources along the reported route the pursuit traveled. The assignment was to review the video files and to provide a summary of any activities observed relating to the pursuit or shooting.

Details

On December 12, 2012 SA Lerussi was assigned to assist in the investigation of an Officer Involved Shooting and Police Pursuit by review of surveillance video obtained from various locations and sources along the reported route the pursuit traveled. The assignment was to review the video files and to provide a summary of any activities observed relating to the pursuit or shooting

On December 19, 2012, the video reviewed can be identified as item 21 from the BCI&I Cyber Crimes lab submission (Exhibit #73 to this file), and reports to be from a surveillance system from the Dollar General Store (number 12184) located at 13711 Euclid Avenue, Cleveland, Ohio (216-249-5436.) The store is located at the intersection of Euclid Avenue and Eddy Road in East Cleveland. The manager who had control of the video system was identified as Robert Kless (DOB 4-21-73.) Mr. Kless provided a copy of the video files covering the requested time period. He labeled the CD/DVD and initialed same in front of SA Lerussi. It was then secured by SA Lerussi.

Item 21 can be described as a CD/DVD with a handwritten and initialed label as described. The disk contains 1 folder named "ARCHIVE_120412_12935 created on 12-4-2012 at 12:39 PM. This date and time is dependent on the computer's date and time being correct and was verified using SA Lerussi's bureau issued cell phone. Inside this folder are 6 items, four of the items are

program files and the remaining two are video clips. The video clips can be viewed using the associated application named "player" also found in the same folder.

The file named "CD_ch12_1129122300_00 reports to be video from camera 12 recorded on 11-29-2012 beginning at 10:30:17 PM. This camera appears to face Euclid Avenue. The file named CD_ch13_1129122230_1129122300_00 reports to be recorded from camera 13 recorded on 11-29-2012 beginning at 10:30:02. This camera appears to face the intersection of Eddy Road and Euclid Avenue and covers the parking lot area as well. The video clips have an embedded date and time created by the system.

Camera 12 10:55:73 A person is observed walking left to right thru the parking lot of the store and along Euclid Avenue to the corner. At the corner other persons are seen standing on the opposite side of the street.

10:58:01 A fast moving car is observed traveling right to left on Euclid Avenue.

10:58:01 – 11:00:01 a total of 51 marked police cars and unmarked cars with emergency lights activated and some without emergency lights are seen traveling right to left on Euclid Avenue. At least one marked patrol car had an all blue light bar activated.

Camera 13. 10:58:35 a marked patrol car is observed traveling right to left on Eddy with emergency lights activated.
