12/18/12 – Receiving a DVD from Regional Transit Police (RTA) of a previous incident involving Malissa Williams (Exhibit #75).



Summary of Events

Incident Cleveland Police Department Pursuit/Shooting 11/29/2012


On December 18th, 2012 Detective David A. Jacobs obtained a DVD from Sergeant King, Greater Regional Transit Authority Police (RTA), phone (216)575-3931. The DVD allegedly contains video footage of MALISSA WILLIAMS, date of birth (DOB) 06/20/1982, social security account number (SSAN) [REDACTED] WILLIAMS was stopped by RTA Police at East 24th Street and Euclid Avenue, Cleveland, Ohio on November 28th, 2012 at approximately 10:00am. WILLIAMS was stopped and cited by Patrolman David James, RTA Police for "evading a fare." WILLIAMS was "run" thru OHLEG due to the fact that she did not have identification at the time of her stop. WILLIAMS was cited, released and the ticket was filed with the Cleveland Municipal Clerk of Courts.
