Findings

The twelve (12) submitted Glock 9mm Luger caliber semi-automatic pistols, **Items #5-9 and 11-17** were all previously test fired and the bullets were examined and retained for comparison purposes. All of the barrels from the twelve (12) Glock pistols have six sided polygonal rifling in a right twist.

The fired cartridge cases from **Items #87 and 91** were previously examined and documented in the report dated December 11, 2012.

Items recovered from scene

Item #59 (Placard #45) was examined and found to contain one (1) fired 9mm Luger caliber bullet exhibiting six sided polygonal rifling in a right twist.

Item #87 (Placard #74) was examined and found to contain one (1) fired bullet fragment exhibiting polygonal rifling and one (1) fired 9mm Luger (+P) caliber Speer brand cartridge case. The cartridge case was previously examined.

Item #88 (Placard #75) was examined and found to contain one (1) fired bullet fragment exhibiting polygonal rifling.

One (1) fragment was from a fired bullet jacket and contained polygonal rifling. The second is a lead fragment with no observed rifling but is consistent with being from a bullet core.

Item #176 was examined and found to contain two (2) fired bullet jacket fragments with polygonal rifling.

Item #177 was examined and found to contain one (1) minute lead fragment. No rifling was observed on the fragment.

Item #240 was examined and found to contain one (1) fired 9mm Luger caliber bullet exhibiting six sided polygonal rifling in a right twist (recovered from the clothing of Malissa A. Williams).

Item #216 was examined and found to contain one (1) fired 9mm Luger caliber bullet exhibiting six sided polygonal rifling in a right twist.

Item #217 was examined and found to contain one (1) fired 9mm Luger caliber bullet exhibiting six sided polygonal rifling in a right twist.

Item #219 was examined and found to contain one (1) fired 9mm Luger caliber bullet exhibiting six sided polygonal rifling in a right twist.

Item #220 was examined and found to contain one (1) fired 9mm Luger caliber bullet exhibiting six sided polygonal rifling in a right twist.

Item #221 was examined and found to contain one (1) fired bullet jacket fragment exhibiting polygonal rifling.

Item #222 was examined and found to contain one (1) fired 9mm Luger caliber bullet exhibiting six sided polygonal rifling in a right twist.

Item #223 was examined and found to contain one (1) fired 9mm Luger caliber bullet exhibiting six sided polygonal rifling in a right twist.

Item #224 was examined and found to contain one (1) fired bullet jacket fragment exhibiting polygonal rifling.

Item #225 was examined and found to contain one (1) fired 9mm Luger caliber bullet exhibiting six sided polygonal rifling in a right twist.

Item #226 was examined and found to contain one (1) fired bullet fragment exhibiting polygonal rifling. A possible hair was removed from bullet, sub-exhibited and will be returned with the evidence.

Item #227 was examined and found to contain one (1) fired bullet jacket fragment exhibiting polygonal rifling.

Item #228 was examined and found to contain one (1) fired 9mm Luger caliber bullet exhibiting six sided polygonal rifling in a right twist.

Item #229 was examined and found to contain one (1) fired bullet jacket fragment exhibiting polygonal rifling.


Item #230 was examined and found to contain one (1) fired bullet jacket fragment exhibiting polygonal rifling.

Conclusions

The submitted bullets and fragments that exhibit rifling have corresponding discernible class characteristics with the submitted Glock 9mm Luger caliber semi-automatic pistols, **Items #5-9 and 11-17**; however, due to the lack of sufficient reproducible individual characteristics from the firearms an identification or elimination could not be made.
