Findings

Officer Wilfredo Diaz

The Glock 9mm Luger caliber semi-automatic pistol, model 19, serial number MPD905, **Item #5**, was examined, test fired and determined to be operable. Six (6) submitted cartridges were used for testing and will be returned with the evidence. Also submitted in **Item #5** was one (1) Speer Gold Dot brand 9mm Luger (+P) caliber cartridge recovered from the firearm chamber and a magazine loaded with twelve (12) Speer Gold Dot brand 9mm Luger (+P) caliber cartridges.

The maximum capacity for the magazine in **Item #5** is fifteen (15) cartridges.

Microscopic comparisons of **Items #107** (Placard 95), **153** (Placard 141) and **155** (Placard 143) with the test fired cartridge cases from **Item #5** revealed matching breech face shear marks and firing pin impressions confirming they were fired from **Item #5**.

Also submitted in **Item #8** was one (1) Speer Gold Dot brand 9mm Luger (+P) caliber cartridge recovered from the firearm chamber and a magazine loaded with eleven (11) Speer Gold Dot brand 9mm Luger (+P) caliber cartridges.

The maximum capacity for the magazine in **Item #8** is fifteen (15) cartridges.

Microscopic comparisons of **Items # 19** (Placard 5), **20** (Placard 6), **21** (Placard 7) and **26** (Placard 12) with test fired cartridge cases from **Item #8** revealed matching breech face shear marks and firing pin impressions confirming that they were fired from **Item #8**.

Results

DNA profiling was performed using the polymerase chain reaction at the short tandem repeat loci D8S1179, D21S11, D7S820, CSF1PO, D3S1358, TH01, D13S317, D16S539, D2S1338, D19S433, vWA, TPOX, D18S51, Amelogenin, D5S818, and FGA on samples from Items 233, 234, 237, and 238.

The DNA profile from the swab from the mouth of the can (Item 233.1) is consistent with Malissa A. Williams.

The DNA profile from the swab from the ends of the pipe (Item 234.1) is a mixture. The major profile is consistent with Timothy R. Russell. The minor profile is from two individuals.

Conclusions and Statistical Information

Malissa A. Williams cannot be excluded as the source of the DNA from the swab from the mouth of the can. Based on the national database provided by the Federal Bureau of Investigation, the expected frequency of occurrence of the DNA profile from the swab from the mouth of the can (Item 233.1) is 1 in 188,800,000,000,000,000 unrelated individuals.

Timothy R. Russell is not the source of the DNA from the swab from the mouth of the can.

Timothy R. Russell cannot be excluded as the major source of the DNA on the swab from the ends of the pipe. Based on the national database provided by the Federal Bureau of Investigation, the expected frequency of occurrence of the major DNA profile from the swab from the ends of the pipe (Item 234.1) is 1 in 58,170,000,000,000,000 unrelated individuals.

Due to insufficient minor data, no conclusions can be made regarding Malissa A. Williams as a contributor to the DNA on the swab from the ends of the pipe.


Remarks

Items 233.1 and 234.1 were consumed during analysis. Should independent analysis be requested, additional samples may be obtained from Items 233, 234, 237, and 238. All remaining evidence will be returned to the submitting agency.

DNA analysis was not performed on Item 11.1. It is our opinion that the DNA analysis procedure most likely to produce a DNA profile from Item 11.1 requires consuming the entire sample. Written authorization from the prosecutor is required before testing can begin on this sample.

The forensic DNA profiles developed were not suitable for CODIS entry.

DNA comparisons can be made if a reference standard consisting of two oral swabs from Officer Randy Patrick's submitted.
